INTRODUCTION

The Committee under the mandate given to them by the members, prepare the Club's By-Laws.

They are for all members' needs and the quiet enjoyment of facilities. The Committee and appointed Management are responsible for ensuring these By-Laws are adhered to.

1. CLUB TRADING HOURS

Bar trading will occur within these hours and may be extended by the Manager or Committee for special occasions as deemed necessary, providing the hours comply with those of the Liquor Control Victoria and other permits, in respect to Clubs. Meals will be served for lunch and dinner seven days. Or at managers discretion.

SUNDAY: 10am - 12am MONDAY - THURSDAY: 10am - 1am FRIDAY - SATURDAY: 10am - 3am

2. DRESS REGULATIONS

Neat and Casual Attire is required at all times. Management reserves the right to refuse entry. Members and Guests must have made a conscious effort to adhere to Knox Club dress guidelines.

2.1 ACCEPTED ATTIRE

Neat and Clean attire at all times to include clean footwear.

2.2 NOT PERMITTED ATTIRE

Dirty Work boots, Singlets, Tank Tops and Work Overalls

No headwear other than by special arrangement / medical or religious reasons

The committee / management prefer that all members and guests accept the responsibility of adhering to these regulations without causing management to intervene.

3. BEHAVIOUR

Members will behave in a proper manner without causing any inconvenience to other members and guests. The term "behaviour" is to include dress, language, actions or any annoyance, which in the opinion of the Committee/Management is detrimental to other Members and the reputation of the Knox Club. Members are solely responsible for their guests and their behaviour. Failure to comply with proper behaviour will result in members being asked to leave the premises and a subsequent report will be lodged with the Committee. Their determination of the infringement may result in suspension or expulsion for the member involved. Persons leaving the premises late in the evening will be expected to leave the property in a manner that does not unduly disturb neighbouring residents.

3.1 COMMITTEE POWERS

The Committee is empowered to expel, suspend or cancel memberships if members are satisfactorily proven guilty of misconduct. This shall include conduct unbecoming of a member, infringements of Club Rules and By-Laws and conduct prejudicial to the Club's interests.

4. CHILDREN

It is the sole responsibility of a member or guest to ensure the proper conduct of their children (minors) and if in the opinion of the Management the behaviour is not satisfactory, the member will be asked to leave the premises. Children (minors) will be allowed to attend the Club under strict supervision of the parent or guardian whilst such persons agree briefly in attendance at the Club and will be restricted to the Legends Bar, Bistro and deck. Duration of the visit to be at the discretion of Management but no later than 9pm daily, unless attending a private function.

4.1 PROOF OF AGE

The Management / Committee reserves the right to require a person believed to be underage to provide proof of age in the form of an approved ID as outlined by the Liquor Control Victoria. If there exists reasonable grounds of doubt on the information provided, the person will be asked to leave the venue or if accompanied by a legal guardian refrain for drinking or entering restricted areas.

4.2 RESTRICTED ACCESS

Any person under 18 years may not enter or remain in a restricted area including smoking areas as designated by the Knox Club and must not play any machine provided for entertainment in any area of the Knox Club.

4.3 PARENTS RESPONSIBILITY

It is the responsibility of the parents or guardian of a minor to ensure the minor does not enter a restricted area.

5. CAR PARKING

At the entrance to the Club there are designated places for the Committee / Life Members and accessible parking. These are not to be used any time by members or guests other than those for whom the spaces are legitimately reserved for.

6. SMOKING

Smoking is permitted only in the designated external areas. No smoking is permitted directly outside the front entrance of the club. No smoking shall occur where meals are consumed. Minors are not permitted in any smoking area.

7. ENTERTAINMENT CONDITIONS

At all times, members or guests shall comply with liquor licencing current rules while in the restricted area of the Knox Club premises. While notwithstanding the entirety or intention of the rules, the following are reflected within the rules:

- a. Entry to restricted area
- b. Dress
- c. Sobriety
- d. Cause damage or physical abuse to an entertainment machine

- e. Behave offensively
- f. Commit or ordering another person to commit an offence against Gaming Machine Control Act 1991.

8. FOOD SAFETY

In the interest of food safety all food purchased must be consumed on the premises. Leftover food must not leave the club for any reason.

Management or Committee reserve the right to refuse entry.
